



Significant Accounting policies & Notes to Accounts forming part of the Annual Accounts for the year ended 31st March 2023

1. Background :

MAHARISHI DAYANAND COOP. GROUP HOUSING SOCIETY LTD was incorporated in 1983 for the purpose of acquire the land and construction of residential houses/flat for giving its members.

2. Basis of preparation:

The financial statements have been prepared and presented under the historical cost convention on the accrual basis of accounting, unless otherwise stated, and comply with generally accepted accounting principles, statutory requirements prescribed under the Delhi Co-operative Societies Act, 1972, the Accounting Standards ('AS') issued by the Institute of Chartered Accountants of India ('ICAI').

3. Property , plant and equipment (Fixed Assets):

- a) Property, plant and equipment (Fixed Assets) are stated at cost of acquisition less Depreciation and impairment losses. The cost includes taxes, duties, freight and other incidental expenses relating to acquisition and installation.
- b) Depreciation on Fixed Assets has been provided on written down value method as per rates prescribed under Income Tax Act 1961.

4. Revenue Recognition

- a) Revenue has been recognised when there is reasonable certainty of its collection on the ground of prudence.
- b) The Members deposit & delayed payment interest received from members as well as interest paid to contractor, if any, during the period is accounted for on receipt/payment basis.

5. Employee Benefit Expenses

Society is of the view that no contractual or legal obligation shall arise to the concern in respect of employee benefits. Therefore, no provision for employee benefits has been made as warranted under AS - 15.

6. Provisions, contingent liabilities and contingent assets:

A provision is recognized when the Society has a present obligation as a result of past event where it is probable that an outflow of resources will be required to settle the obligation, in respect of which a reliable estimate can be made. Provisions are not discounted to its present value and are determined based on best estimate required to settle the obligation at the balance sheet date. These are reviewed at each balance sheet date and adjusted to reflect the current best estimates. When there is a possible or a present obligation in respect of which the likelihood of outflow of resources is remote, no provision or disclosure is made.

Contingent assets are not recognized in the financial statements. However, contingent assets are assessed continually and if it is virtually certain that an inflow of economic benefits will arise, the asset and related income are recognized in the period in which the change occurs.

3. Previous year figures have been re-grouped/re-arranged wherever necessary.





PREVIOUS AUDIT OBJECTIONS AND COMPLIANCE THERE OF

AUDIT OBJECTIONS

1. The society has started to following the budgetary system for collection from the members and expenses from the F.Y. 2021-22. The society has prepared cost estimated of the project and the payment plan.
2. The society is taking necessary steps to collect outstanding dues and interest for delayed payments from defaulting members. In doing so there are two of its appeals are pending before the Hon'ble Delhi Cooperative Tribunal with effect from 08.05.2017 and 09.10.2021 respectively. The Tribunal has directed 12 members to pay Rs 52 lakh in next 15 days from its order dated 22.07.2022.
3. The society is taking action to complete the formalities in respect of 18 members enrolled in the earlier years. At present two Revision Petitions in respect of Smt. Simmi Kapoor and Sh. Manohar Verma versus Registrar Cooperative Societies are pending before the Hon'ble National Consumer Disputes Redressal Commission with effect from 03.03.2022. The society is awaiting outcome of those two revision petitions of the members.

COMPLIANCE

1. The society has started to following the budgetary system
2. All the respondents have deposited the amount upto Rs 52 lakh except one respondent. The Tribunal has been informed accordingly. The next hearing of these appeal is on 18.09.2023 and 20.09.2023 respectively.
3. The Society is still awaiting outcome of those two revision petitions of the members.

PART -B**GENERAL COMMENTS**

- (a) The Society operates from its Registered Office at B-4 (adjoining B-5/ B-6 DDA Flats), Vasant Kunj, New Delhi -70. Members are allowed to inspect documents of the society which are available there at registered office of the society.
- (b) The controlling statements have been prepared on the lines indicated under Delhi Coop. Societies Rules and countersigned by the office bearers and auditors.
- (c) The members account at the close of the co-operative year are reconciled. The difference identified on such reconciliation belongs to a period prior to the date 01.04.2007 and has been shown separately under current Liabilities. This has been brought before the Managing Committee in its meeting held on 08.07.2023. The committee after due deliberation unanimously decided that amount shown in liability should be settled after taking approval of the coming Annual General Body meeting.
- (d) All bank accounts except that of Punjab National Bank-Saving A/c 01012191001536 are reconciled with the bank statements and passbook. The society has a non-operational bank account with Punjab National Bank-Saving A/c 01012191001536 which had a balance of Rs. 51,660.00 As informed to us, there were no transaction in the said bank account for a long time however no bank statement available with society.
- (d) The society has not borrowed any Funds during the current audit period.
- (e) The society has not raised any debt. Hence, Debt Equity ratio is not applicable.
- (f) The society has not granted any loan to any member or any outside party.
- (g) The Term of previous Managing Committee Expired as 05.10.2022. The Registrar of Cooperative Society, Delhi had appointed an Administrator vide Order No. 107704781/RCS/S-IV/2022/936-939 Dated 31.10.2022 (Copy Enclosed). Administrator conducted elections on 26.02.2023 and present Managing Committee was elected.
- (h) As informed to us there are seven legal cases pending at various courts or forums where society is a party. A list of the same is provided and submitted along with audit annual accounts.
- (j) During the year, One Annual General Body Meetings (AGBM) and two Special General Body Meetings (SGBM) were held. Beside these nineteen Managing Committee Meeting (MCM) of the society were also held during the year. Minutes of all these meetings are available.




(k) List of members with their ledger balance at the close of the year enclosed to the audit annual accounts. The control account of the member deposit is reconciled with individual members ledger and the difference identified since prior to 01.04.2007 has been shown as current liabilities. This has been brought before the Managing Committee in its meeting held on 08.07.2023. The committee after due deliberation unanimously decided that amount shown in liability should be settled after taking approval of the coming Annual General Body meeting.

(l) As informed to us, none of the office bearer of the society suffers from any disqualification contained in the Act.

(m) The schedule of fixed assets is enclosed with the balance sheet. The same are periodically reviewed by the society is not enjoying any cash credit limit based on goods hypothecated by the society.

(n) Since the formation of the present Managing Committee, major expense was incurred after approved in Managing Committee Meeting from October, 2019 onwards.

(o) The society is not thrift & Credit Society or Co-operative store. Hence there is no cash credit limit, which need to be reviewed.

(p) The records of the society are kept at registered office of society. A certified list of records is enclosed.

(q) A list of various bank accounts maintained by the society is enclosed. The accounts are reconciled regularly with the balance as per the banks. Certificates of bank balance at the close of the year have been obtained and are enclosed with the report.



BALANCE SHEET AND INCOME EXPENDITURE ACCOUNT

1. The society, after its formation, had purchased a piece of land for construction of flats for its members in the Revenue Estate of Kasoompur in New Delhi in 1990. The DDA issued notification dated 07.06.1990 under section 4 and 17 of the Land Acquisition Act, 1984 for acquiring of said land. The society assailed the aforesaid notification in writ petition before the Delhi High Court. The society was allotted land at Vasant Kunj, New Delhi in exchange of its Land in the Revenue Estate of Kasoompur in New Delhi on 04.09.2009 after a prolonged litigation up to the level of the Hon'ble Supreme Court of India.
2. The society carried out the preliminary works at site during some time in 2010. These preliminary works were construction of boundary walls, levelling of ground, rock cutting, removal of fly ash from the site, soil testing, processing of layout and building plans with DDA, payment of charges for not constructing the flats for the Economically Weaker Section (EWS), purchase of FAR, construction of storage facilities and society site office etc. The layout and building plan were approved by the DDA as per Master Plan Delhi-2001 on 22.03.2012. Construction started at the site in July 2012. At the end of the year 2015 the society decided to construct all 4 Bedroom Flats as per MPD-2021. Therefore, accordingly the society filed an interim application before the Hon'ble Supreme Court of India in January 2016. The Hon'ble Court granted the consent of MPD-2021 as requested by the society on 21.11.2016. Thereafter, the society submitted its Revise Sanction Plan to South Delhi Municipal Corporation in the month of May 2017. The SDMC approved the Revised Sanction Plan as per MPD-2021 of the society on 25.04.2018. The RERA registration was done on 02.09.2019.
3. Now a days the society is following the escrow system of payment towards the housing project. In that seventy percent of the amount realized for the project from its members, from time to time, shall be deposited in a separate account to be maintained in a schedule bank to cover the cost of construction and shall be used for that purpose only. Society is withdrawing the amounts from the separate account to cover the cost of the project, in proportion to the percentage of completion of the project. It is stated that this amount is withdrawn by the society after it is certified by an engineer, an architect and a chartered accountant. The society accounts are being audited regularly.
4. Our opinion on the financial information of the entity as a whole is on the basis of the certificates issued by the Chartered Accountants, we rely on the work of other Chartered Accountants as per SA 600.
5. The society has made deduction towards Income tax (TDS) from payments to contractors, as well as professionals etc. where applicable. The amount has been deposited with respective authorities and necessary returned has been submitted to the concerned departments. In few cases, the payment was made late, however interest has been paid on the same and due return submitted.



6. The society continued the process of charging interest from members on delayed payment as per Rule 32 of DCS Rules, 2007. The society received an amount of Rs. 46,68,858 during the F Y 2022-23.

COMMENTS ON ITEMS OF BALANCE SHEET AND INCOME & EXPENDITURE ACCOUNT

Share Capital and Member's Deposits: This includes the Share Money and Member's Deposit (Comprising of Land Money Deposit, Construction Contribution Deposit, Compulsory Deposit and Equalization Deposit) received from members as at the close of the year, following is the summary for the year:

During the year, the society has transferred the membership of nil membership in name of their relatives / relatives- nominees on receipt of request along with necessary documents.

An amount of Rs. 34,93,28,057/- is recoverable from Members on account of construction money as on 31.03.2023.

As explained to us, during the earlier years the Managing Committee of the Society had approved and substituted the name of 18 members based on order of consumer commission during the year 2010-11. The society received two letters on 23.12.2011 and 24.04.2012 from office of the Registrar Cooperative Societies stating that their names are yet not approved by the Registrar. The Registrar Cooperative Societies filed two appeals against the orders of the State Consumer Disputes Redressal Commission in the year 2011. These two appeals were up held by the order dated 11.03.2020. Two members out of these 18 members have filed revision petition against the impugned order dated 11.03.2020 on 03.03.2021 before the National Consumer Disputes Redressal Commission on

03.03.2021. The impugned order has been stayed by the National Consumer Disputes Redressal Commission on 17.03.2021.

The Member wise list of Members deposit at the end of the year is enclosed to annual audit accounts. There are a number of members who have not made full payments of dues demanded by the society till the end of the year. The Managing Committee of the society had issued notices for expulsion to a number of members due to default in payment of outstanding dues and submitted such cases as RCS office.

Reserve and Surplus: This comprises of Statutory Reserve fund amounting to Rs. 8,68,835.98. There has been no change in the said account during the year.

Interest Fund: The society has been receiving interest from members on delayed payments made by them. As per the terms of the agreement with contractor, interest is payable by the Society to contractor on delayed payments made by the society. During the year, there was net addition of Rs 46,68,858 to this account. No payment to contractor on account of Interest on delayed payment was approved by society during year. The interest from members on delayed payments of construction money demanded as well as interest to Contractor for delayed payment of bills by society is accounted for on cash basis.

There has been addition on Building(flats) under construction during the year amounting to Rs 13,19,23,618 on account of payments to contractor & architect, Payments to SDMC and payment of Miscellaneous Site Expenses, details of which are contained in the annual accounts.

No stock of materials is lying with society at the close of the year as the society has adopted the practice of handing over the materials upon receipt to the contractor for usage in construction. Hence all the materials, purchased up to the close of the year, net of recoveries made from contractor, are booked in construction cost (building under construction) at the close of the year. However, due to the practice of handing over of materials at the time of procurement thereof, the internal control over handling/consumption of materials is not completely exercised and society needs to adopt some method whereby internal control over materials can be exercised more strongly.

There is no addition in the Furniture and Fixture, Office Equipment and Computers & Printers during the year.

Investments: The Society has made an investment of Rs 5,000.00 in Delhi State Co-Operative Housing Finance Corporation Ltd. by subscribing to 10 Shares of Rs 500.00 each fully paid up the society is in possession of duplicate share certificate.

Dividend on the same has been accrued during the year.
