MANAGING COMMITTEE MEETINGS

6. The previous Managing Committee of the Society was elected on 12.12.2015. Their term expired on 11.12.2018. Before expiry of term, the managing committee submitted request with O/o Registrar of Cooperative Societies, Delhi for appointment of Returning officer to hold elections. Registrar of Cooperative Society, Delhi had appointed an Administrator vide Order No. I07338047/RCS/S-IV/2019/116 Dated 28.02.2019 to conduct elections. In terms of said appointment, the Administrator conducted the elections on 06.10.2019 and present Managing Committee was elected.

GENERAL BODY MEETING

7. During this quarter, Five Managing Committees Meetings were held on 18.07.2021, 21.08.2021, 29.08.2021, 05.09.2021 and 26.09.2021. Minutes of all the meetings are available.

MEMBERSHIP

8. There were no new enrolments or resignations of Members have been done during the period under audit. As pointed out earlier also, membership of 18 members, whose names were transferred in the year 2010-11 from Society's Register but is still pending for approval from Registrar of Societies.

WORKING

- 9. During the quarter ended on 30.09.2021, construction work has been in progress with follow up of some guidelines issued by Central Government. The contractors did submit bills during the quarter. The payment of overdue outstanding amount from members against demands raised continues to be a concern for the society. As per information provided, subsequent to completion of structural work of all the flats, the finishing work is now going on. As per minutes of MC, the term of existing contract with contractor of the society has been extended with a new supplementary agreement dated on 9th August, 2020.
- 10. During an earlier year, DDA has given permission for construction on the basis of FAR permitted in MPD 2021. However, in the same permission DDA has added one clause which required society to obtain consent of Hon'ble Supreme Court. The society has obtained the consent of Hon'ble Supreme Court in this respect. We have been informed that drawings of the Society were approved by South Delhi Municipal Corporation and required approval fee has already been deposited with SDMC. The society has also been granted registration with RERA.



- 11. During this quarter, the society has collected INR 1,33,68,571/- from members against demands raised and interest levied on delayed payments by members but substantial amounts are still overdue from many members against the demands raised by the society. The society follows Cash method of accounting for penal interest. The society is maintaining an Interest Fund account. Interest received from members on account of delayed payments and interest paid to contractor and / or to any other party on account of delayed payment by the society is recorded in this account. These interests are accounted for on cash basis. Further during the quarter, the Society has collected INR 9,83,06,376/- from members in the name of Member's Contributions.
- 12. Fixed Assets belonging to the society have been duly verified by the Managing Committee. The list of fixed Assets held by society has been certified by the Managing Committee is annexed separately.
- 13. Accounts of the Society are maintained on computer and are complete. The receipts to the members are issued manually.
- 14. The vouchers for payments are approved by the President/ Secretary-in-Charge and were made available to us during audit. There is no Cash-in-hand at the end of quarter and has also been confirmed by the present managing committee members. The day to day expenses of the society are incurred through imprest given to office assistant.
- 15. The services of office and Accounts-in-Charge and the civil engineer were terminated w.e.f. 1st July, 2017. The two employees have filed cases against society against termination of their employment. The society has not appointed new staff during this reporting period.
- 16. Voucher Files for expenses incurred and payments made are maintained and were produced before us.
- 17. The society has no system of making budget and approval thereof.
- 18. As on 30.09.2021, 9 legal cases were pending where either the cases were filed against the Society or in which society was made a party, either before courts or in office of Registrar of Cooperative Societies, Delhi. The details of the same have been given in the list certified by the office bearers of the present Managing Committee of the society, attached separately. It was informed to us that the special audit of the Society, conducted on directions of the O/o Registrar of Cooperative Societies, Delhi, has been completed and the Special Auditor has submitted his report. Copy of the report, however is not available with the society and society has also received no communication from office of RCS in this regard.
- 19. Bank Accounts of the Society are reconciled. As informed to us, the Bank Account with Punjab National Bank (Savings A/c) bearing A/c no. 01012191001536 having balance of INR 51,660.00 (Fifty One Thousand Six Hundred and Sixty Only) is not operative and has no transaction in the said bank account for a long time.
- 20. The Records of the Society are kept at its Registered Office and as explained to us, the same are made available to the members for their inspection, if demanded.



IRREGULARITIES / DISCREPANCIES

- 1. The Society should introduce a budgetary system for collection from members and expenses.
- 2. The Society should take necessary steps to collect outstanding dues and interest for delayed payments from defaulting members.
- 3. The Society should take action to complete the formalities in respect of 18 members enrolled in the earlier years.
