Opinion

We have carried out the concurrent audit of Maharishi Dayanand Cooperative Group Housing Society Ltd., Khasra No. 310, Masoodpur Village (Opp. Imperial Club), New Delhi - 110070 for the period 1st April, 2025 to 30th June, 2025. We have examined the Receipts & Payments Account of the Society for the period then ended, a summary of significant accounting policies, other explanatory information and notes to the financial statements.

A detailed report is being annexed herewith in accordance with the requirements of the Registrar of Cooperative Societies, Delhi and forms a part of this report.

We have obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purposes of our audit. In our opinion, proper books of account as required by law have been kept by the Society so far as it appears from our examination of those books.

In our opinion and to the best of our information and according to the explanations given to us, the Receipt and Payment Account, of Maharishi Dayanand Cooperative Group Housing Society Ltd., for the quarter ended on 30th June, 2025 are prepared, in all material respects, in accordance with Delhi Cooperative Societies Act, Rules and By-laws in the manner so required and subject to and read with our notes, audit objections and observations stated in detailed report annexed, give a true & fair view.

In the case of the Receipts & Payments Account, of all the Receipts and Payments, made during the period ended on that date.

Basis for Opinion

We conducted our audit in accordance with Standards on Auditing. Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the entity in accordance with the ethical requirements that are relevant to our audit of the financial statements and we have fulfilled our responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management and those Charged with Governance for the Receipt and Payment Account

Management is responsible for the preparation of this Receipt and Payment Account in accordance with Delhi Cooperative Societies Act that give a true and fair view of the receipts & payments. This responsibility also includes maintenance of adequate accounting records in

accordance with the provisions of the Act for safeguarding the assets of the society and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the Receipt and Payment Account that give a true and fair view and are free from material misstatements, whether due to fraud or error. In preparing the receipt and payment account, management is responsible for assessing the entity's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the entity or to cease operations, or has no realistic alternative but to do so. Those charged with governance are responsible for overseeing the entity's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to obtain reasonable assurance about whether the financial statements/receipt and payment account as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not a guarantee that an audit conducted in accordance with Standards on Auditing will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements / receipt and payment account.

Other Matters

The Society has not considered in the financial statements, the amount outstanding from members on account of construction money due to the extent of Rs 32,63,17,480/ (as on 31st March 2025) and the penal interest of Rs 27,69,19,472/- (till 31st March 2024) due from defaulting members. No Penal interest calculations were prepared for the current financial year 2024-25. Accordingly, the Current Asset (Due from Members) has been understated to the extent of Rs 60,32,36,952/- and understated the liability on account of interest Fund by Rs 27,69,19,472/- and members deposit by Rs 32,63,17,480/-. Consequent both Assets and Liabilities have been understated by Rs 60,32,36,952/-

MANAGING COMMITTEE ELECTION

6. The term of previous Managing Committee of the Society which was elected on 06.10.2019 has been completed on 05.10.2022, but the election could not be conducted for new Managing Committee within stipulated time. Hence the Assistant Registrar appointed an Administrator on 31st October 2022 for 90 days vide the order no. 107704781/RCS/S-IV/2022/936-939 dated 31.10.2022 to look after the day-to-day affairs and to conduct election. Further a Returning officer is also appointed by Assistant Registrar on 04th January 2023 for 60 days to conduct the election vide order No. 107704781/RCS/S-IV/2022/08-14 dated 04.01.2023. Election has been conducted on 26.02.2023 and a new Managing committee has been elected.

MANAGING COMMITTEE MEETINGS

7. During this quarter, three Managing Committee Meetings were held on 20/04/2025, 18/05/2025 and 15/06/2025. Minutes of all the meetings are available.

MEMBERSHIP

8. There were no new enrolments, resignations, expulsion, substitution or transfer of Members have been done during the period under audit.

As pointed out earlier also, membership of 18 members, whose names were transferred in

the year 2010-11 by the society are not yet regularized by the Registrar Cooperative Societies. Two revision petitions of Smt. Simmi Kapoor and Sh. Manohar Verma v/s Registrar Cooperative Societies and Others are still pending before National Consumer Disputes Redressal Commission.

WORKING

9. During the quarter ended on 31.12.2023, construction work has been stopped by the Municipal Corporation of Delhi. A notice from MCD was issued on 03.10.2023 for stoppage of construction activities due to expiry of validity of building plan / permit on 24.04.2023. Further a Show Cause Notice (SCN) u/s 345A of The DMC Act 1957 has been issued on 17.10.2023. Society has submitted the reply against the said SCN on 20.10.2023. But MCD

has issued an order for the sealing of the premises. The premises mentioned above remain sealed by the MCD as on the date of the audit report.

- 10. The society got consent of the MPD 2021 from Hon'ble Supreme Court of India on 21.11.2016. Thereafter, application for revision to the earlier layout and building plan dated 22.03.2012 was submitted in the month of May 2017 to SDMC. The SDMC approved the revised layout and building plan on 25.04.2018. The society also got registered under RERA on 02.09.2019.
- 11. The amounts collected during the quarter and amounts due from members towards construction money and interest on delayed payments as on 31-12-2024 are listed below.

Substantial amounts of construction money and interest are still overdue from many members. Society follows recoverable basis method of accounting for interest on delayed payment, but interest on delayed payment have been accounted for only up to 31st March 2024. Based on discussions with the Accountant, interest for the period from 1st April 2024 to 30th June 2025 will be recorded as and when it is approved in the Managing Committee (MC) meeting.

The society is maintaining an Interest Fund account. Interest received from members on account of delayed payments and interest paid to contractor and / or to any other party on account of delayed payment by the society is recorded in this account. Payments against the housing project construction are also made from this account.

- 12. Fixed Assets belonging to the society have duly been verified by the Managing Committee. The list of fixed Assets held by society duly certified by the Managing Committee is annexed separately.
- 13. Accounts of the Society are being maintained on computer. The receipts to the members are issued manually.
- 14. Vouchers for payments approved by the President/ Secretary/Treasurer were made available to us during audit. There is no Cash-in-hand at the end of quarter and has also been confirmed

by the present managing committee members. The day-to-day expenses of the society are incurred through imprest given to society engineer.

- 15. Voucher Files for expenses incurred and payments made are maintained and were produced before us.
- 16. The society has started to follow the budgetary system for collection from the members and expenses from the F.Y. 2021-22. The society has prepared cost estimated of the project and the payment plan.
- 17. The list of legal cases pending in different forums, filed by or against the society as on 30-06-2025, have been duly certified by the office bearers of the present Managing Committee of the society, attached separately.
- 18. It was informed to us that the special audit of the Society, conducted on directions of the O/o Registrar of Cooperative Societies, Delhi, has been completed and the Special Auditor has submitted his report. Copy of the report is available with the society and society has also forwarded the Action Taken report to office of the Registrar Cooperative Societies. On 22.09.2023 vide order no. F.C.D. 107338097/RCS/H-Sec-4/2022/6131-6133, the Registrar of Cooperative Societies has issued an order to dispose of the proceedings initiated u/s 66(2) of the DCS Act.2003 vide Show Cause Notice dated 02.01.023.
- 19. Bank Accounts of the Society are reconciled. As informed to us, the Bank Account with Punjab National Bank (Savings A/c) bearing A/c no. 01012191001536 having balance of INR 51,660.00 (Fifty One Thousand Six Hundred and Sixty Only) is not operative and has no transaction in the said bank account for a long time. The management has indicated that this matter will be discussed during the next managing committee meeting to decide on an appropriate course of action.
- 20. The Records of the Society are kept at its Registered Office and as explained to us, the same are made available to the members for their inspection, if demanded.
- 21. The society has been facing numerous challenges due to its current address. To address this recurring issue, the managing committee passed a resolution during its meeting on October 12, 2024, to change the society's address to Khasra No. 310 (Opposite Imperial Club), Masoodpur Village, New Delhi-110070. Subsequently, on October 18, 2024, the society submitted a formal request to the Registrar of Co-operative Societies for approval of the address change.
- 22. Some members had unpaid dues exceeding 65% of the total amount payable as of 30th June 2025 (i.e., demand amount plus interest payable up to 31st March 2024). As per discussions, it was indicated that demand notices will be issued to these members for the recovery of the outstanding payments, following the directions of the committee. Additionally, interest on

these dues will be recorded as and when it is approved in the Managing Committee (MC) meeting.

RREGULARITIES / DISCREPANCIES

- 1. The society has started following the budgetary system from the F.Y. 2021-22. But limited only on cost estimation of the project and its payment plan. Estimation on collection from the members and on general expenses is yet to be implemented.
- 2. The society has account for interest on delayed payment only up to 31st March 2024.

We are thankful to the office bearers/staff members of the Society for extending cooperation during the audit.
